## **City Attorney Report:**

Stuart Symmonds related conversations with Frontier Development Group about a signed agreement for RHID. It was shared that a request has been received for a letter to pay an additional \$32,500. Mayor Sisson requested more investigation/clarification before issuing a letter.

#### **Mayor Report:**

Mayor Sisson reported that we need to choose a different date for our fireworks. July 3,2025 was chosen, and the mayor will notify our fireworks personnel.

## **City Clerk Report:**

A motion was made by Spinden and seconded by Carathers to have the Clerk prepare a letter to KDOR to add a new point of contact of Mike Hastings, Council President and update authorized users for tax matters with the State of Kansas. Motion carried without opposition.

A motion was made by Spinden and seconded by Hastings to contact Citizens State Bank to remove former Council members and staff as authorized signers. Motion carried by unanimous vote.

Hastings moved and Carathers seconded to approve a Special Event Request for a "Hands Off Rally" to be held April 19, 2025. Motion carried without opposition.

A favorable consensus was reached by Council on the following:

- Provide trash containers & collection for Flint Hills Rodeo in exchange for advertising.
- Announce April 26, 2025, for Twin Cities Garage Sales free dump day.

### **Utilities Supervisor Report:**

Supervisor Gumfory reported that bids have been received for street repairs. Mayor Sisson requested the Supervisor to refine projects to trim costs closer to last year's cost of \$180,000. The need for a

It was announced by Carathers that the action to be taken was to conduct a background investigation and upon positive results an offer be extended to the candidate just interviewed. Hastings was assigned to that task.

There were no updates to be discussed by the committees.

Hastings moved to pay checks 33590-33614+11 EFTs for payroll. Carathers seconded and motion carried unanimously. Hastings moved to pay checks 33615-33636 for bills. The motion was seconded by Kewley and passed unanimously.

Hastings moved to adjourn the meeting at 8:14 PM. Motion was seconded by Kewley and passed unanimously. Meeting adjourned at 8:14 PM.
