**Community Relations:**

- P. Larkin and Gumfory met with Bill Yeager regarding drainage issues at north end of Pine Street and alleges that it was changed when the Linns built their house. Mayor Sisson, P. Larkin, & Gumfory will meet to talk through drainage solutions. B. Larkin to look into pictures of the property when it was a cement plant to ascertain the drainage situation at that time.
