

# CITY OF COTTONWOOD FALLS

## **ORDINANCE No. 1004**

**AN ORDINANCE AMEND ARTICLE 2 OF CHAPTER 16 OF THE CODE OF THE CITY OF COTTONWOOD FALLS, KANSAS 1976 AS AMENDED, AND ORDINANCE NO. 993 AND ESTABLISHING NEW AND DIFFERENT RATES FOR THE SALE OF WATER.**

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COTTONWOOD FALLS KANSAS:**

**SECTION 1.** Articles 16-201, 16-202 and 16-203 of the Code of the Cottonwood Falls, Kansas, 1976, as amended, Ordinance No. 851, and all other ordinance in conflict with this ordinance are hereby repealed and the following provisions are enacted in lieu thereof:

### **16:201. METER FEE.**

The following is hereby established as a fee for each active water of the water distribution system of the **City of Cottonwood Falls, Kansas:**

- a. Meter Fee: \$20.01

### **16-202 RATE SCHEDULE: WITHIN CITY LIMITS OF COTTONWOOD FALLS:**

- a. The following rate is hereby established for all water furnished and delivered by and through the water system of the **City of Cottonwood Falls, Kansas**, to water customers within the city limits of the **City of Cottonwood Falls:**

(1) For each 1,000 gallons per month: \$12.22

### **16-203 RATE SCHEDULE: OUTSIDE THE CITY LIMITS OF COTTONWOOD FALLS:**

- a. The following rate is hereby established for all water furnished and delivered by and through the water system of the **City of Cottonwood Falls, Kansas**, to water customers outside the city limits of the **City of Cottonwood Falls:**

(1) For each 1,000 gallons per month: \$13.97

**SECTION 2:** The **City of Cottonwood Falls** will annually increase the water rates by 2% to cover the increases incurred due to the costs of goods and services.


**SECTION 3:** All ordinances and parts of ordinances in conflict herewith are hereby repealed.


