## **ORDINANCE NO. 981**

AN ORDINANCE PERTAINING TO THE DISCHARGE OF VEGETATION, DIRT, WASTE, TRASH OR OTHER DEBRIS UPON CITY STREETS IN COTTONWOOD FALLS, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COTTONWOOD FALLS, KANSAS:

**Section 1:** That it shall be unlawful for any person or persons to throw, rake, deposit, dump, drop, spill or discharge any dirt, compost, waste material, litter, trash, leaves, grass, weeds or other debris upon any city street. This shall specifically include the discharge of grass clippings or other mower discharge upon city streets. The owner of any property is responsible for any activity upon his or her property which causes said discharge.

Section 2: Definition of City Street, for purpose of this ordinance only, does not include alleyway.

Section 3: Any person found in violation of any provision of this ordinance shall, upon conviction thereof, be fined in a sum not to exceed One Hundred Dollars (\$100.00) or be imprisoned for a period not to exceed thirty (30) days, or by both such fine and imprisonment.

**Section 4:** This Ordinance shall take effect and be in force from and after its passage and after its publication one (1) time in the official city newspaper.

## **AMENDING ORDINANCE 981**

AN ORDINANCE PERTAINING TO THE DISCHARGE OF VEGETATION, DIRT, WASTE, TRASH OR OTHER DEBRIS UPON- CITY STREETS IN COTTONWOOD FALLS, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF COTTONWOOD FALLS, KANSAS:

Section 1: That it shall be unlawful for any person or persons to throw, rake, deposit, dump, drop, spill or discharge any dirt, compost, waste material, litter, trash, leaves, grass, weeds or other debris upon any city street. This shall specifically include the discharge of grass clippings or other mower discharge upon city streets. The owner of any property is responsible for any activity upon his or her property which causes said discharge.

Section 2: Definition of City Street, for purpose of this ordinance only, does not include alleyway.

Section 3: Any person found in violation of any provision of this ordinance shall, be given notice of said violation and correct the same within 24 hours.

Section 4: Any person found in violation of any provision of this ordinance and fails to correct the same within 24 hours shall be assessed a fee upon the water bill for the residence.

Section 5: A fee for the violation shall be assessed to the water bill of the property the following month in the amount of \$50 for the first violation, \$75 for the second violation and \$100 for each violation thereafter.

Section 6: This Ordinance shall take effect and be in force from and after its passage and after its publication one (1) time in the official city newspaper.
