September 4th, 2018**

The regular meeting of the City of Cottonwood Falls City Council was called to order at 6:00 p.m., September 4th, 2018 at the municipal meeting room. Agenda

Utilities Supervisor Report

- No Parking Signs were placed along main street at LMI from the highway to just west of the alleyway.

- The crew is waiting on parts to finish replacing a waterline on Sycamore. Hoping to finish that up within the next week.
- Jones met with The Law Company on Wednesday to discuss the possibilities of splitting of the cost of resurfacing State street and Friend due to the construction work at the high school. A letter will be sent to The Law Company to confirm the offer.

City Clerk's Report

- Council reviewed pet impound policy. No action taken.

Sisson's Report

- Sisson has been working with US Cellular on an ongoing lease agreement for them to install a cell tower north of the biodiesel plant, just south of the lagoons.
- Sisson has been looking into getting internet in the council room and the community building. No action taken.
- Council discussed allowing out of town residents to hook up to city water. No action taken.

Carathers Report

- Carathers has a meeting set for the 13th of September to finalize Chase Disc Golf Tournament details for the 27th of October.

Larkin's Report

- Larkin has been working an ongoing Broadband Internet project that recently received a proposal to do a study regarding cost, phases, wireless, poles, underground, pros and cons, along with possibilities of recommendations.

Sturms motioned to approve a total of 10 hours of overtime. Hastings seconded. Motion carried.


Accounts Payable
