Mayor's Report

- Sturms made a motion to approve Resolution 2016-1 entering into a Lease Purchase Agreement in the amount of \$60,000 with Cottonwood Valley Bank to purchase a 2008 Kenworth Loadmaster 20 yard T370 trash truck. Terms include a 4 year lease with quarterly payments of \$4,055.80. Larkin seconded the motion. Motion carried.
- A notice has been drafted to send out to water customers notifying them of the date and time
 of the implementation of the new water system. The notice will be hung on the doors, put in
 the paper and sent out as a bulk mailing. PWWSD #26 will inform the City of the date that the
 water can be switched.
- Clerk Bohnen will get in touch with Wausau to see if they offer a similar drinking fountain as the one quoted that is self-draining.
- The consensus of the council is to proceed with the limestone welcome marker on the North end of town for an estimated additional cost of \$4100. Jones may begin working on prepping the footing.
