- The City has received a letter from the Kansas Housing Resources Corporation stating that Tom Bishop of Homestead Affordable Housing, Inc. has informed them that he does not intend to implement the Grant Agreement dated October 11, 2013 wherein the City was awarded a grant of \$100,000 to be used for the construction of ten single family homes for moderate income households. The letter was intended to notify the City that KHRC is withdrawing the grant.
